



## Siting and Permitting

In our experience, siting representation often encompasses numerous ancillary matters in addition to permit applications and proceedings. This includes matters such as obtaining necessary real estate interests (including the acquisition of fee parcels, licenses, permits, and easements); dealing with title, appraisal, and survey clearance issues; condemnation and valuation proceedings; real property assessments and tax issues; construction contracting (and related labor, insurance and claims work); and a broad range of other permitting-related activities. We assist our clients with these issues as and when they arise, and we also routinely provide advice with regard to:

- Air and water quality

- Federal and state environmental compliance
- Significant wildlife and habitat concerns
- Solid waste disposal
- Stormwater discharge

In 2014, shortly after PSEG Long Island commenced operation of the Long Island Power Authority's electric transmission and distribution system, the firm initiated work on a number of LIPA's siting matters, including Article VII projects.
